

This policy statement generally covers all the work carried out by the operating branches of Keller Limited (UK and Eire), and sets out the management system requirements for them. Keller Ltd, also represented as Phi Group and GEO-Instruments, is a specialist contractor providing geotechnical solutions, foundation structures, measurement monitoring and surveying services to the building and civil engineering sectors.

The company operates under a certified Integrated Management System (IMS) in accordance with the requirements of; ISO9001 Quality Management Systems, ISO14001 Environmental Management Systems and ISO45001 Occupational Health and Safety Management Systems. This policy is communicated to all employees and to other persons working for the company. It is made available to other external stakeholders as required and is available via the Keller website.

Policy Statement

Keller meets its customers' expectations by providing them with a quality assured service.
